The USASF administers courses that certify all star cheer and dance judges on all aspects of safety and legality in their respective genre. These courses are designed to prepare judging candidates to judge safety and legality at USASF member event producer events.

The USASF is pleased to announce the Safety Judges Certification course is also open to All Star Cheer Coaches who wish to become more versed in the legality rules. Coaches who choose to audit these courses will receive the same education and training as the safety judges.

DATES & LOCATIONS

This summer the USASF will offer the safety judge certification courses at the six Regional Meeting locations. The cheer safety judge training will be held at all six locations while the dance safety judge training will be offered at four of the six locations.

All courses are open to all star coaches to "audit" while the safety judge candidates are being trained.

ALL STAR CHEER RULES TRAINING & SAFETY JUDGE CERTIFICATION

This full day, classroom style course, includes an overview of all rules at each level. It will include some examples of what can be performed within these rule limits, and a look at the elements that make skills "illegal".

AUDIT—RULES COURSE

ALL STAR DANCE RULES TRAINING & SAFETY JUDGE CERTIFICATION

This is a classroom style course that will include a review of all dance category and division guidelines as well as a complete review of skills. Material will include video and written notes.

AUDIT—RULES COURSE

10:00 a.m. to 2:30 p.m.

Fee: \$55.

The course fee includes lunch and training. Coaches will sit-in with the safety judge candidates as the rules are explained in detail.

FREQUENTLY ASKED QUESTIONS

Do I have to be recommended by an event producer to become a judge?

No. The safety judge training is open to all qualified judging candidates. Although we prefer a recommendation from at least one event producer it is not required to attend and complete the certification process.

Can I take both the cheer and dance safety judge courses?

Yes. You may take both courses if you like. Each course and certification is run independent of the other and are scheduled at different times so that you may partake in both certification courses.

Am I required to register for the Regional Meeting if I only want to take part in the safety judge training?

No. You are welcome to attend the safety judge training without attending the Regional Meeting. However, coaches who wish to AUDIT the rules course must also register for the Regional Meeting to be eligible to attend.

How should I prepare for the safety judge certification test?

Each attendee is required to print off and bring with them the most current version of the rules and glossary. It is suggested that you spend some time prior to the seminar and certification familiarizing yourself with the changes or additions and note any questions you may have. You should be familiar with the layout of the rules and be able to easily navigate through the text to find the information quickly. To download your copy visit www.USASF.net and select SAFETY.
